Bell County District Attorney Henry Garza (pict. middle left) visited the Temple Founder Lions Club on Wed. August 22.

Henry Garza, a native Texas, is a graduate of Killeen High School. Henry received his Bachelor of Arts degree from Austin College in 1978 and, after being awarded his Doctor of Jurisprudence degree from Texas Tech University, was licensed to practice law in Texas in 1981. Henry worked in the Bell County Attorney's office and prosecuted misdemeanors from 1983 until 1986. He then worked as an Assistant District Attorney for Bell County for fourteen years. Henry was elected to the honor of serving as District Attorney for Bell County, Texas and took office January 1, 2001, and is currently serving his fourth term.

Henry spoke to us on the state of Bell County as it pertains to the justice system. He noted that Bell County is experiencing tremendous population growth and as it increases, so does crime. One troubling factor is the increase of homicides in the past 3 years. D.A. Garza is pushing to get these cases resolved in a quick manner. He also informed us that every two years, legislation is passed that changes how our criminal justice system functions. Another issue that he feels needs more attention is the state of mental health and identifying those with mental health problems.

Ultimately, D.A. Garza's goal is to rehabilitate and release people that have entered our local criminal justice system.
